



CONTEST RULES-General

Kinder Productions, Inc. (Kinder Outdoors), WBAP 820AM-KO Network of radio stations and show distributed through the Salem Radio Network on numerous stations and SiriusXM-Rural Radio Channel 147

Contests are open to all legal residents of the continental United States 18 years of age or older. Not eligible: Employees of Kinder Productions, Inc., News/Talk 820 WBAP, All KO Radio Stations in Network and Salem Radio Network and all stations in network, SiriusXM, Rural Radio, Citadel Broadcasting Corporation, their parent, affiliate, subsidiary, or successor companies, advertising and promotion agencies, contest prize suppliers, participating advertisers, sponsors, and immediate family members of the above are not eligible to participate in this contest. If there is a conflict between the general rules and specific rules of a contest, the specific rules will govern. Examples of such conflicts include an extended time in which to claim a prize or eligibility restrictions.

Contest entries must include entrant's name, address, and daytime and evening telephone numbers, and email address if available. When individual contests require, birthdate must also have to be included.

LIMITATIONS: One winner per household, listeners can only win one Kinder Outdoors contest (including, but not limited to: phone in, email, or postal entry) once every 60 days. If a contest requires telephone or fax entries, sponsors are not responsible for the inability of caller to complete the call within specified time whether due to telephone equipment malfunctions, disconnections, busy lines, or other circumstances. Only calls to the designated telephone number will be eligible to win. If a contest requires mail entries (postal or electronic), Kinder Outdoors and its sponsors are not responsible for the timeliness of delivery or electronic malfunctions that may effect the delivery or content of the entry, neither are they responsible for misdirected, illegible, postage-due, or lost mail. Entry forms not received by a contest deadline or which are not complete or legible will not be considered. Decision of the judges as to eligibility of entries is final. All participants agree to be bound by these rules. Any contest is void where prohibited by law. All federal, state, and local laws and regulations apply. Winner is solely responsible for payment and reporting of taxes on any prizes valued over \$600.00. Kinder Productions, Inc. will provide a 1099, in the year the prize is claimed, for the value of prize.

PRIZES: Prizes are specified within individual contest rules. Prizes are non-transferable and non-exchangeable (Unless ruled appropriate by the judges at the time of dispersing). Prizes have no cash value. No substitution, credit or cash equivalent will be made or given. Kinder Outdoors, reserves the right to substitute a prize of equal or greater value, as determined solely by Kinder Outdoors, if the awarded prize is unavailable for any reason.

CLAIMING THE PRIZE: Winners agree to receive prizes in person at specified locations (radio station) and must: (1) provide proof of age and identity (photo identification a must), and (2) execute an affidavit of eligibility, indemnification, and release. All prizes must be claimed and received within 30 days of winning, unless otherwise specified in the specific contest rules. Some smaller prizes can be mailed, so long as winner completes a mail release form and also provides copy of photo identification. Failure to comply with these requirements will result in forfeiture of the prize. Unclaimed prizes will not be awarded. All federal, state, and local laws and regulations apply. All federal, state, and local taxes are the sole responsibility of the winner.
